**BN/28/21 – 26 Wentworth Close, Barnham** – Single storey rear extension including demolition of existing conservatory and part conversion of garage to habitable use.

**BN/35/21 – Land north of Sunnyside Cottages, Yapton Road, Barnham -** Variation of Condition 2 imposed under BN/5/20.

**BN/36/21 – 20 Elm Grove, Barnham –** First floor extension over existing garage and porch to front

BN/37/21 - 2 Field Cottages, Church Lane, Barnham - Fell 1 Eucalyptus Tree

**BN/38/21 – Angels Nursery, Yapton Road, Barnham** – construction of feature entrance wall set back from access to approved residential development

BN/43/21 – 25 Skylark Way, Barnham - extension to garage and redesign roof

5. To note responses to the following applications have been submitted to Arun District Council following approval via an email exchange as per the Committee's Terms of Reference

BN/18/21 – GTR land east of Fontwell Avenue, Eastergate - light industrial floor space. The Committee resubmitted the comments it made to the previous application on this site that related to the design of the building and the need for an assurance that the use of chemicals in the factory will not find their way into the local water supply. In addition, the response asked that comment be made as to why the trees have been downgraded in category and by whom and also expressed concerns over the proposed lighting scheme due to the presence of bats in the location.

6. To note decisions taken by Arun District Council since the last meeting of the Committee

**BN/4/21 – Magnolia Cottage, Fontwell Avenue, Eastergate** – Proposed two-storey rear extension. Approved conditionally. The Committee submitted a 'no objection' response.

**BN/10/21 – 2 Park Cottages, Goodacres, Barnham** – Loft conversion consisting of hip-to-gable roof extension and rear box dormer with roof windows to front elevation. Approved conditionally (glazed window to east elevation). The Committee submitted an objection on grounds of size of extension and impact of design on the area.

**BN/5/21 – 4 Dial Close, Barnham** – Single storey side extension. Approved conditionally. The Committee submitted a 'no objection' response.

**BN/14/21 – The Old Vicarage, Church Lane, Barnham** – Fell 1 Eucalyptus, Prune 1 Scots Pine and Reduce height of 1 Liquid Amber Tree. No objection. The Committee agreed to support the Tree Officer's recommendation.

**BN/3/21 – St Philip Howard School, Elm Grove, Barnham** – Installation of canopy to courtyard to increase dining space for pupils. Approved conditionally. The Committee submitted a no objection response to the application.

**BN/158/20 – Deep End, Lake Lane, Barnham** – Ground floor front extension and Porch, First floor side extension. Approved conditionally. The Committee submitted a no objection response to the application.
