

# Barnham and Eastergate Annual Assembly 2024

#### Introduction

In reviewing the last year, we can't ignore the topics of flooding, drainage, sewage, road closures, potholes and anti-social behaviour. We have had an unprecedented two public meetings in recent months to address public anxiety and questions. The first was with Andrew Griffith MP on 26<sup>th</sup> January at Eastergate Village Hall and the issues raised were the very high levels of housing development imposed upon our area, recent road closures and foul water drainage capacity. The second meeting was with the Police and Arun's Anti-social behaviour team on the 4<sup>th</sup> of April at Barnham Community Hall to address the scourge of antisocial behaviour and shoplifting in Barnham Village centre which came into sharp focus over the Easter weekend when four girls were arrested at Barnham Station.

It is shocking to me that we have been alerting the District and County Council for over a decade that our villages need community infrastructure<sup>1</sup> investment to make up for an existing deficit and to support future housing growth. This year we hit a tipping point which brought issues including poor infrastructure maintenance and underinvestment into sharp focus. Your Parish Councillors and staff are really focussed on lobbying the authorities that can help, both now and in the future, to take the actions necessary to support our community.

The time we spend on big topics like drainage, highways, policing, is not wasted but it is deeply frustrating as we are reliant on other authorities to prioritise their resources and provide funding. However, over recent years, we've developed a modest Strategic and Community Infrastructure Investment programme of our own to address the things we can control and invest in. I'm delighted to report that we have made very real progress as was described in our August 2023 Community Newsletter.

Everything we do is driven by a team of up to 13 elected Councillors (we currently have 11 Councillors so have 2 vacancies for anyone interested in joining), 3 members of staff and many volunteers. On everyone's behalf I'd like to thank our councillors for their service and dedication to our community. I'd particularly like to highlight the work of our Clerk, Alison Crabb and our Assistant Clerks, Nina McMaster, Sarah Jolley (who left us in October to move to Australia) and Gemma Hindson who joined us to replace Sarah. These are challenging roles particularly given the ambition of this Council and I'd like to thank them for their fortitude and commitment. Without them we would not have been able achieve as much as we have.


## **Organisation and Governance**

Over recent years, particularly since the merger of Barnham and Eastergate Councils in 2019, we have been building capacity in terms of staff and volunteers to provide a Parish Council that has the ability to represent and support our local community and not be just a talking shop. A close partnership with Barnham and Eastergate Community Trust has further enabled us to leverage grant funding and provide financially sustainable and well-run community facilities.

Over the last year we have made huge progress in bedding in an organisational structure of sub-committees and working parties. This is very important because it increases our capacity and empowers smaller teams of councillors and staff to get things done without feeling too much of the weight of Parish Council rules and bureaucracy.

It also enables councillors to focus on topics or interests that motivate them personally and enables volunteers to be co-opted onto projects without worrying about becoming over-committed. The current structure is shown below:

# **Planning and Environment**

We have a well-established Planning and Environment Committee that meets in public and is chaired by Sue Wallsgrove. This team are the guardians of our Neighbourhood Plan and notably representing protection of the environment in our parish. Our Neighbourhood plan does not give us complete protection from predatory housing developers and central government policy, but it is used to regularly send a clear message to politicians and policymakers as to how we want our villages to develop and how we want our rural environment to be preserved. As parliamentary election season approaches, we expect the roles of Neighbourhood Plans to strengthen and politicians and press will start listening more. The 'mood music' from the current government is that this will happen throughout 2023 and 2024.

For Planning and Environment, it has been a more than challenging year with the losses suggesting that central government policy is favouring development at any cost. Whilst the losses may be more readily remembered there have been some robust victories and we've successfully pushed back on some inappropriate development. In addition, valuable working relationships have been formed with major housing developers and generally these have borne fruit with developers changing their masterplans to deliver on some of our environment concerns even after a housing development has secured planning permission.

However, the pressures on this team created by the commercial interests of housing developers, poor political support from higher authorities and a poorly implemented Arun Local Plan has been immense and, at times, very demoralising. We must thank Sue and the rest of the Planning & Environment Committee, past and present, for their tireless efforts. At the March meeting of the Committee Sue Wallsgrove stood down as Chair and was replaced by Chris Wells, but Sue will remain a member of the Committee.

The topic of greatest concern is ensuring that the infrastructure to support the combined scale of all the housing developments in our parish is adequate and is delivered first. This is a major unresolved challenge that is not in the gift of the Parish to resolve. It is also a challenge that is inadequately supported by the District and County Councils.

## **Strategic Plan**

This is a huge topic too large to cover in detail here, but we are in the process of updating it as we do every year. I'd encourage every resident to review and have an opinion on it as it contains the following:

# **Barnham and Eastergate Parish Council**

#### Strategic priorities

These are in addition to the core objectives of the Parish Council and identify what we will focus on over the next five years. The current priorities being proposed for adoption are:

- Places, People & Spaces: Develop projects and initiatives to increase community engagement, volunteering and community cohesion.
- Community Programmes: Facilitate programmes to coordinate, grow and develop the work of the
  volunteer led organisations in the villages to increase social connections and reduce loneliness. Our
  ambition is to deliver a vibrant and interesting range of clubs, societies and events that are valuable
  alternatives to other, more chargeable leisure pursuits which are typically 8 to 10 miles away.
- **Community Resilience:** Develop a defined plan and deployment processes supported by a stock of equipment and PPE to enable a local response to emergencies.
- Expand Village halls, Sports Facilities and Children's Equipped Play Areas: Capital investment
  programme funded through Precept, Community Infrastructure Levy (CIL) and S106 contributions.
   Objective is to increase the accessibility, range of services and capacity of our community/village halls,
  playing fields and equipped play spaces.

### **Community Infrastructure Investment**

Barnham and Eastergate already has 15% of Arun's proposed housing development with only 3% of its current total population and the questions about the plans to deliver the facilities we need are endless but cover the following topics:

- Highways and transport Roads, public transport, the needs of non-car users
- Healthcare Doctors, dentists ...
- Education School places
- Flooding and drainage
- Green infrastructure
- Library services
- Social infrastructure Community halls, sports facilities

We have been working on this topic since 2019 creating the evidence base and reports to demonstrate that Arun District Council and West Sussex County Council need to create robust delivery plans. I'm saddened to report that there is lots of political posturing but little in terms of plans. I would characterise the main issues as:

- Major road schemes such as the A29 realignment, the Fontwell roundabout, the A27 Arundel bypass are
  all being developed in isolation with no wider area masterplan or strategy. For commercial and financial
  reasons there is low confidence in the integrated delivery of these schemes and a realistic fear that the
  villages will become grid-locked with traffic.
- In terms of the other items there is simply not enough money being committed to deliver the social infrastructure that any community should have.

## **Community Programmes**

Whilst Planning, Environment and Community Infrastructure somewhat dominates, the Parish Council has been keen to deliver benefits to our community in terms of funded programmes and we have committed staff and money to support this ambition. Over the past three years our delivery partner, the Barnham and Eastergate Community Trust has run a growing range of activities to address community cohesion. These programmes have reached many people, enabling them to make new friends and develop new interests. The programmes are very inclusive from babies/toddlers, through to the elderly; people with health problems such as alcoholism and diabetes, through to fitness classes, films and concerts, sports and interests, social events and activities to combat loneliness. Between the Trust and the Parish Council we have raised nearly £230,000 in grants since the start of the pandemic in 2020.

# **Volunteering**

Our eternal thanks must go to the volunteers and staff who have developed The Barnham and Eastergate Community Trust and the Parish Council over more than 20 years; built a Neighbourhood Plan that has legal powers; supported fundraising events too numerous to mention and; secured major grants. This has enabled us to secure the funding and services that our community deserves in an environment where higher authorities are cutting budgets and many cherished community services.

If you think you might be interested in knowing more speak to any of the Parish Council or Trust staff.

At this particular point in time we need to recruit new Trustees to the Board of the Barnham and Eastergate Community Trust. If you think this might be of interest to you then please speak to myself or Terry Bedford the current Chair of the Trust.

Please tell us what is important to you. It is vital that all residents and the Parish Council have a two-way conversation so we can address concerns and take action. We are working on improving our website and social media coverage.

Big issues such as planning and development are important, but we maintain focus on every aspect of our community life to help make our villages good places to live, learn, work and play. Your Parish Council can hear your concerns about many matters including our Parish Facilities (sports fields and halls); planning applications; litter bins; car-parking and road user behaviour; anti-social behaviour; drainage and much more. The Parish Council is rarely the decision maker, but we can contact the relevant authorities and advocate for change.
