

MINUTES OF THE ANNUAL PARISH ASSEMBLY OF BARNHAM AND EASTERGATE PARISH HELD ON TUESDAY 30th APRIL 2024 BARNHAM COMMUNITY HALL

The Barnham and Eastergate Annual Parish Assembly for 2023 took place on 30th April at Barnham Community Hall. The event was once again publicised as a Community Engagement Event and brought about another encouraging turnout of residents and local organisations.

1. Welcome

The meeting was hosted by the Parish Council and would have been Chaired by Chris Allington (the newly elected Chair of the Parish Council). Unfortunately illness had befallen him and Chris Wells (Chair of the Council's P&E Committee) kindly stepped in to welcome everyone, both the exhibitors and residents, and to thank them for taking the time to attend the event.

2. Annual Report of the Chair of the Parish Council for 2023-24

The following are the details from the short presentation given by Chris Wells on behalf of Chris Allington which highlight what the Parish Council can do to support the community it serves, a summary of the key points contained in the full copy of the report which is appended to these minutes; and a few facts and figures about how Council Tax payments made by residents funds WSCC, ADC, the Police and the Parish Council.

Parish Councils

- Parish Councils are the tier of local government closest to their electorate and best placed to serve local communities
- However, our powers are limited in that many of the things we would like to do for the community require the agreement and involvement of higher authorities
- We do
 - Give views on behalf of the community, on planning applications and other proposals that affect the Parish
 - Alert relevant authorities to problems that arise or work that needs to be undertaken
 - Work with higher authorities to achieve improvements and solutions to local issues
 - Develop and maintain a Neighbourhood Plan which has statutory weight when responding to planning applications
 - Invest in our community infrastructure using S106 receipts, Community Infrastructure Levy (CIL) receipts and grants.

Summary Points from the Annual Report


 Your Parish Council has established several Working Parties to focus on key areas where we can make a difference most of which are represented here at this meeting

3. Approval of Minutes of Annual Parish Assembly held on 23rd May 2023

The minutes were approved and the Chair signed a copy.

4. Presentation by Sue Wallsgrove, Arun District Councillor

Sue Wallsgrove gave a very brief summary of the flooding and sewage issues that had besieged the Parish this winter. In particular she mentioned the tanker operation in Barnham Lane/Lake Lane that had taken away over 350,000 litres of water per day during the months they were in operation and was pleased to report they had now left the site. She is working with Southern Water to help ensure anit flood devices and solutions are provided to homes directly impacted by flooding and sewage issues. She acknowledged that Southern Water had now completed repair works to the sewers in Barnham Road and Elm Grove but these were not permanent solutions to the problems that will continue unless proper investment is put into the infrastructure. She along with other Councillors will continue to lobby against any new homes being connected to the sewers before or unless infrastructure investment takes place. Penny Wycherley proposed a vote of thanks to Sue Wallsgrove and County Councillor, Trevor Bence, for all their work on the Parish's behalf to support residents during these times.

5. Presentation by Parish Councillor Simon Parkin

Simon Parkin gave a short presentation on the work of the new Communications Working Party that had recently been established by the Parish Council to look at new and different ways to improve communications between the Council and the residents of the Parish. One of the new initiatives will be the production of a monthly newsletter giving brief updates on what the Council has been doing and continues to do for residents and other items such as litter picking events, events at our Community Halls etc. The main purpose of this presentation, however, was to encourage people to sign up to receive this newsletter which will be circulated through email and published on the Council's website each month.
