Address: Land South of Wandleys Lane Eastergate PO20 3SE

**Application details:** Application for construction of 10 No dwellings with new access from Wandleys Lane, landscaping and areas for ecology & amenity space. This application is a Departure from the Development Plan and is in CIL Zone 3 and is CIL Liable as new dwellings. **Committee response:** The Committee resolved to submit an objection. The Committee stated that the application goes against BEPC NP Housing policy H1 9.5 and footpath and cycleways, section 3.12.

## Application number: BN/36/25/PL

Address: The Co-operative Food 1 Steeplechase Way Barnham BN18 8UF Application details: Installation of an air conditioning unit, refrigeration pack and condenser at the rear of the building. This application is in CIL zone 1 (zero rated). Committee response: The Committee resolved to submit a no objection response.

#### Application number: BN/53/25/PL

Address: Land off Highground Lane Barnham

**Application details:** Change of use from agriculture to recreation/leisure use for private use. This application may affect the character and appearance of the Church Lane, Barnham Conservation Area, affects a Public Right of Way, is a Departure from the Development Plan and is in CIL Zone 3 (Zero Rated) as other development.

**Committee response:** The Committee resolved to submit an objection. The Committee stated that the application goes against BEPC NP policy ES1b Reducing flood risk

**Address:** The White House Church Lane Eastergate PO20 3UR **Application details:** 1 No. Yew (T1) crown lift on the east to 2m from ground level and pruning of 5 limbs on the north-east to leave a length of 4m. **Committee response:** The Committee resolved to support the views of the ADC Tree Officer

**Address:** Barnham Court Church Lane Barnham PO22 0BP **Application details:** Fell 1 No. Holm Oak (T1) and fell 2 No. smaller Holm Oak (T2, T3). ## 9.3 Litter issues around the Parish

An AI generated discussion mp3 on the latest litter picking activities was prepared by Andrew Crawford and played for the Committee. The main points of the discussion were:

- A total of 28 volunteers took part in April's record-breaking litter pick with 57.7kg of litter collected, including 1.9kg of cans and 9.1kg of plastic/glass bottles that will now be recycled properly.
- Litter pickers were rewarded with post-pick pastries provided by the staff at Brnham Community Hall as part of the volunteer coffee morning.
- The litter pickers have reserved a stall at the May Fair event on Saturday 24<sup>th</sup> May to engage with the community with the sweeping challenge and other fun, litter-based games.
- Considerable volunteer resource has been dedicated to litter picking data capture to understand behaviours and inform future activity.

It was agreed that Andrew Crawford would attend the next P&E meeting in July.

- Details of the OnePlanet for Town and Parish Councils on Tuesday 27<sup>th</sup> May 2025 was shared with committee members by the Assistant Clerk.
- The Assistant Clerk reported that a local resident had made contact regarding the possibility of the council funding small projects to increase biodiversity in the villages such as the installation of bird boxes and the selection of plants and seeds to attract local wildlife.
- Following the request for an urgent consultation response on the upgrading part of Footpath 146 at Barnham and part of Footpath 153 & all of Footpath 147 at Flansham to a Bridleway, and adding a length of Bridleway was submitted by the Assistant Clerk on behalf of BEPC, which stated that there was no opposition, it was noted that further information on the subject had been brought to the attention of the Chair.
- Both Assistant Clerks attended the WSALC Clerks Networking Day at Billingshurst Community Centre on Tuesday 13<sup>th</sup> May, which included a presentation on the latest planning updates.
