10.3 Litter issues around the Parish

The Assistant Clerk gave an update on recent litter picking activity in the Parish. The main points of interest were:

- 21 volunteers attended the June litter pick and collected 41kg of litter from which 10.2kg of recycling was 'saved'.
- Public voting analysis on bins and litter from the May Fair was to be completed by the July pick.
- Heat maps from GPS data was to be made available online to volunteers by the July pick.
- A guide to what the picking means was to be circulated to councillors along with achievements, failures and tasks remaining for 2025.
- The sign-in retention policy has been made clearer following the GDPR seminar.

10.4 Flooding issues around the Parish

It was noted that despite an increased frequency of gully inspections, emptying and upgraded equipment with the WSCC contract, there was an ongoing issue with the flooding of gully E24552 which had forced people to avoid using the traffic light crossing.

The Assistant Clerk mentioned the following matters:

- A request from Peter Cleveland from Henry Adams had been received in which he had asked the Committee to review their objections to application BN/46/25/PL. The Assistant Clerk noted that a response had been sent stating that the Committee had not been minded to change their decision.
- The Assistant Clerk had circulated a WSCC Highways maintenance update and survey to members of the Committee
- Following a request by the applicant of BN/53/25/PL to review the objection that had been submitted by the Committee, the Assistant Clerk noted that the Committee stood by their original objection.
